fees charged and regular use. Any use going forward where users are charged a fee from the leader members could be charged less than others from the community or a donation could be made to the church. Any congregational needs that are met through services provided at the church are different than community members using our building and charging an entry fee. Shandy motions to amend the free space agreement to stipulate that we evaluate the rental differently and consider a fee based on whether anyone approaches us and will profit from said event held in the building verses we approach someone to fill a need for the congregation. Ken seconds the motion. The vote passes.

Capital Campaign "Making all things new" (Pastor Scott)- The Awareness Campaign in fall of 2022 prioritized Making all things new. Joe Mueller and the Property Team has created a five year plan for the upcoming needs for building repair. The highest priority is the stained glass windows. Making all things new is a scripture quote that is used in describing the stain glass windows. Each of the windows have themes, the scripture used for the window on the right is making all things new. The bid is based on looks, but the Capital Campaign Team would like a contingency amount, a small percentage for just in case, for a total of \$32,000. The Capital Campaign would like to present this plan at the Spring Congregational meeting for approval. If approved, the first week of June they want to send the materials to everyone in the church with a pledge program. They will accept one time gifts/donations, or monthly pledges. Any pledges would be due back the middle of July and then receive gifts roughly August through July 2024. Ken moves we go ahead with the first phase of All Things New Campaign to commence in June of 2023. Bill seconds the motion. Any money raised beyond will be set into a building fund for future repairs. Vote passes. The Spring Congregational Meeting will be May 21. At the meeting all needs and asks for the future should be presented.

St. Benedict's Coordinator for Ozaukee County (Pastor Scott)- The Coordinator Joann Perringer is stepping aside and would like for someone to take it on. She has come to our church to ask if anyone here is interested. Joann left the staff with a job description. Pastor Scott is asking if we should pursue this as part of our church's mission. We would be a center hub with a coordinator or two. The third Thursday of the month all year. We should post the need in the newsletter and arrange to meet with Joann if anyone is interested, but as a church we don't feel we are in a position to coordinate at this time as it seems we can't fill our own vacancies. The meeting with Joann will be second Tuesday in May on the 9th if anyone is interested in learning more.

Any other new business to come before the Council?- Bill has brought an article from the Press with regards to ARPA money that we may qualify for a portion of the grant money for capital projects.
